Shall the Board of Education of the North Platte County R-I School District. Missouri, without an estimated increase in the current debt service property tax levy, borrow money in the amount of Six Million Two Hundred Thousand Dollars (\$6,200,000) for the purpose of providing funds for the site development, construction, equipping and furnishing of a new Junior High School building; to repair and replace roofs, including a portion of the Elementary School roof: to the extent funds are available, complete other remodeling and repair improvements to the existing facilities of the District; and issue bonds for the payment thereof? If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$0.9900 per one hundred dollars of assessed valuation of real and personal property.
